## IFOPE Public License Agreement (in short)

*The International Flag of Planet Earth* is free to use for both personal and commercial purposes – under two conditions:

- a) **The flag is only to be used to represent the astronomical body of planet Earth.** The flag does not represent a business, organization, or an individual.
- b) **Honoring the original Work;** The original flag ratio is 2:3, however, the rectangular shape of the design may vary depending on its usage (i.e. circular, square, triangular, etc.). In all cases, keep colors and the emblem design intact.

## IFOPE Public License Agreement

### *The International Flag of Planet Earth (IFOPE)*

#### License

THE WORK IS PROTECTED BY COPYRIGHT. ANY USE OF THE WORK OTHER THAN AS AUTHORIZED UNDER THIS LICENSE OR COPYRIGHT LAW IS PROHIBITED.

**BY EXERCISING ANY RIGHTS TO THE WORK PROVIDED HERE, YOU ACCEPT AND AGREE TO THE TERMS OF THIS LICENSE.**

#### 1. Allowable Uses.

The intended use rights ("Intentions") are:

- a) **to represent the astronomical body of planet Earth;** not a business, organization, brand, community or individual; thus no trademark/logotype is accepted (see Restrictions below).
- b) **to honor the original Work;** thus no changes to the emblem design or colors are allowed, however the rectangular shape of the design may vary depending on the use.
